UNEXPLODED ORDINANCE AREA (UXO) INFORMATION

Key Message

Upon mobilisation to a UXO area, additional information will show within P1 Mobile and the SMS dispatch message.

One of three categories will be displayed as follows:

- Slight (SLT),
- Substantial (SUB) or,
- Other (OTH).

What's been happening?

Previously when responding to incidents, awareness of UXO areas has relied upon local knowledge. This has significant risks when crews are unfamiliar with the area or responding from out of district.

What has changed?

The UXO message will now be included for incidents that are on undeveloped land.

The UXO message will inform responding crews of the need to follow

<u>SOP 3.5.13 - Operating Within Registered UXO Sites</u>, or consult the relevant Urban Bushfire Response Plan
