THE PAFTACS CHALLENGE - UPDATE

As per Operational Circular 78/2019, SitReps are an important method of communicating with ComCen and the Regions to increase situational awareness and identify support. The acronym we use to provide this first informative message at bushfires is **PAFTACS**. To encourage early and accurate PAFTACS, the ComCen is holding a <u>CHALLENGE</u> over the High Threat Period – **THE PAFTACS CHALLENGE**!

On 11 December 2019, a number of appliances were mobilised to a Grass/Scrub/Bush Fire in Yanchep. Two Rocks Light Tanker advised ComCen en route that there was a large visible smoke plume and confirmed air support would be required. They then arrived and classified 3rd Alarm.

Shortly after, Butler Fire Station crew arrived and provided the following PAFTACS.

"Confirmed 3rd Alarm Grass Scrub, approximately 2 Ha, moderate rate of spread, approximately 5 hours to control, require Police for traffic management, Communications Plan is MNC5, incident will be known as Yanchep Control, winds 15-20km easterlies, Control Point is on Wanneroo Road at Butler Pub, contact Coordinator Public Information to assist putting out an Advice"

Congratulations to the Two Rocks Light Tanker crew and Station Officer Halleen from Butler FS for providing excellent examples of early SitReps.

Key Message

PAFTACS should be used as a first informative by Incident Controllers to increase situational awareness and identify support. Well done to Two Rocks and Butler crews for the initial communication provided at the Yanchep Fire
