RAPID ALERT CALLER ID

DFES Operational Communications Branch is continuing to improve the Rapid Alert Application which DFES uses to send operational text messages. Rapid Alert has recently been upgraded and it is necessary to inform end users that the Rapid Alert Caller ID will change. As a result, personnel should reconfigure their personal devices so that Rapid Alert notifications can be heard when the device is on 'Silent' or 'Do Not Disturb'. Refer to Annex A for instructions.

DFES and the Rapid Alert service provider Soprano Design recently signed off on a new Service Level Agreement that will provide an improved and more reliable messaging service. In order to provide a faster messaging service with higher availability. It has been necessary to introduce a pool of phone lines. As a result, end users will see different numbers appear on their Caller ID when a Rapid Alert message is received.

As of 25 May 2019, the following numbers will be used by the Rapid Alert application;

The numbers above should be saved in your phone under a single contact entitled 'Rapid Alert'. The contact should be configured for "Emergency Bypass" to enable notifications to be heard while the device is on Silent or Do Not Disturb.

Key Message

Text Messages generated by Rapid Alert will utilise different Caller IDs. Personnel and volunteers who receive Rapid Alert Messages in the course of their duties should reconfigure their personal devices to accommodate the change.

Third party applications such as BART and Swiftworks may need to be reconfigured to enable the application to consume Rapid Alert messages. Users of third party applications should contact the application vendor for technical support.

- 3. In 'Settings' go to 'Do Not Disturb' and then 'Allow Exceptions' and tick 'Favourites'.
