
PHASE ONE OF AUSTRALIAN WARNING SYSTEM (AWS) TO GO LIVE IN SEPTEMBER

Key Message

As part of the implementation of the Australian Warning System (AWS), bushfire warning colours in Western Australia will change from 14 September 2021.

What you will notice:

- New warning *colours* for Bushfire only. Bushfire warning colours will be updated to reflect the national framework (Advice – Yellow; Watch and Act – Orange; Emergency Warning – Red).
- Icon style changes for all hazards on Emergency WA in line with AWS standards.



This change is the first step in a phased implementation of AWS. Subsequent phases will see the new framework introduced for other hazards beyond bushfire.

What's been happening?

The DFES Public Information Branch has been working with all impacted business areas to identify systems, doctrine, training products and community education resources that require updating to align with the AWS icons and colours for bushfire.

What does it mean for me?

The implementation introduces several changes that will impact Operational personnel:

- Updated Doctrine (SAP 3.2.B Public Information and Warnings, Bushfire Talking Points, FG 3.2 Public Info Media Points). Updated documents will be made available for pre-season forums and training.
- New colours and icons will be visible on Emergency WA, WebEOC, FESMaps, the DFES corporate website and across relevant Community Preparedness resources from 14 September.

A range of communication activities will be undertaken to inform volunteers, DFES personnel and local governments about the colour change. Additional information will be provided through the media and digital channels to ensure the community understands what the new colours mean.
