BUSHFIRE WARNING COLOURS AND ICONS HAVE CHANGED

Key Message

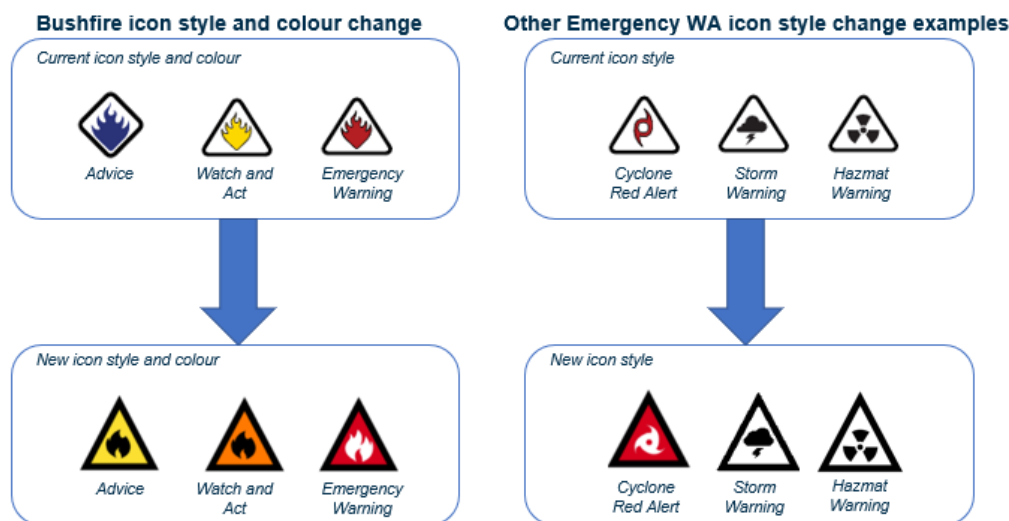
Bushfire warning colours and icons in Western Australia have now changed as part of the implementation of the Australian Warning System (AWS).

What you will notice on Emergency WA and other operational systems:

- New warning *colours* for Bushfire to reflect the national framework as per the image below:



- Icon *style* changes for all hazards on Emergency WA in line with AWS standards as per the image below:

This change is the first step in a phased implementation of AWS. Subsequent phases will see the new framework introduced for other hazards beyond bushfire.

What does it mean for me?

These changes impact Operational personnel in the following ways:

- Updated Doctrine (SAP 3.2.B - Public Information and Warnings, FG 3.2 -Public Info Media Points) is now available.
- Updated Bushfire Talking Points now available on the [IM Toolbox](#).
- New colours and icons are now visible on Emergency WA, WebEOC, FESMaps, the DFES corporate website and across relevant Community Preparedness resources.

It's important to note that there are no specific changes to the warning levels for bushfire and that alerts and warnings will still appear on Emergency WA, as Western Australia's trusted source of emergency information.

What do I need to do?

Familiarise yourself with the new bushfire warning colours and icons on Emergency WA.
