2023/24 METROPOLITAN BUSHFIRES CALL FOR OBSERVATIONS

Key Message

DFES Metropolitan Operations is undertaking a Themed Analytical Review (TAR) that will encompass bushfire response across the four Metropolitan Regions during the 2023/24 High Threat Period. Anyone who was involved in frontline operations, evacuation centres, Incident Management Teams, Communications Centre, Metropolitan Operations Centre, or Incident Control Centre's are invited to provide input by submitting their observations to the DFES Lessons Management Observation Register.

What is happening?

This call for observations follows on from the December 2023 Mariginiup Call for Observations (Operational Circular 88/2023). Given the high operational tempo experienced during the High Threat Period, the Metropolitan Operations Leadership Team are undertaking a combined TAR to identify key insights from feedback to improve operational performance.

In accordance with SAP 3.19.B DFES, Metropolitan Operations is now requesting observations on what went well, what didn't go well, what can or can't be sustained, what areas can be improved and why.

Some of the larger incidents the TAR will focus on include :
