AERIAL FIREFIGHTING CESSATION DATES

Key Message

The following information outlines aerial firefighting cessation dates for the 2023/24 southern bushfire season.

What happened?

The contracted service periods of aerial firefighting aircraft supporting the 2023/24 southern bushfire season have been extended due to prolonged bushfire risk.

What does it mean for me? / What do I need to do?

Aerial firefighting aircraft will continue to be available to support Operations as detailed below. Further, aerial firefighting mobilisation according to automatic and enhanced response zone procedures will continue as per each Region's High Threat Period; reference Operational Circular 16/2024.

Resources extended until close of business 22 April 2024:

Jandakot

- 1 x Air Intel Aerial Intelligence Surveillance Reconnaissance helicopter.
- Up to 2 x Helitaks (Bell 214B with 2,650lts per aircraft), depending upon availability on the day.
- 1 x Air Attack supervision helicopter (AA5).
- 1 x Air Attack supervision and utility helicopter (AA7).

<u>Gingin</u>

• 2 x Helitaks (Bell 214B with 2,650lts per aircraft).

Serpentine

• 2 x Helitaks - High Volume (Black Hawk with 4,500lts per aircraft).

Busselton

- 2 x Helitaks (Bell 214B with 2,650lts per aircraft).
- Large Air Tanker (B737 with 15,000lts) and Birddog aircraft

Retardant bases; Busselton and RAAF Pearce operational.
